Tega Cay Tennis Association

- Included in your tennis membership will be automatic enrollment into the Tega Cay Tennis Association. The association exists to promote the game of tennis and enhance camaraderie among the members.
- Members receive a periodic newsletter and exclusive tournament information
- Tennis tournaments and events include a variety of formats and socials.

Benefits/Conditions

- Members have the use of four courts adjacent to the water tower on the far side of the new community center
- Parking is available in the general clubhouse parking lot
- Food and Beverages may be purchased at the Clubhouse or Pavilion
- Members must use the sign-up sheets when using the courts
- Time limit of recreational play is 1 hour for singles and 1.5 hours for doubles, unless no one is waiting to utilize the court
- There is a 15-minute wait for late arrivals before the court is considered open
- Year-round key access for members only
- Proper attire is required and defined as follows: flat-soled shoes, shirts, shorts or pants. *Swimwear, tank or tube tops, spiked shoes or dress shoes are not permitted.*

Unattended Children

- We anticipate a crowded parking lot with mixed use from tennis, golf, trail walkers, and the community center. Therefore, we ask you not to leave your children unattended while using the tennis courts.

Guest Policies

- Guests may use the facility up to three times, provided a member accompanies them. This guest policy does not apply to team players.
- All USTA or Combo team players using this facility must purchase a membership.
- The only exception to this policy will be that non-members may participate in clinics

Director of Tennis

- Tanner Haddon is our USTPA Director of Tennis. He can be found at the tennis pro shop, Tuesday-Saturday from 10AM-4PM during the months of March-October.
